ORDER

On September 8, 2025, Lost City Renewables LLC (Lost City Renewables) filed a notice of substitution of David Crouse, P.E., in place of Sean Joshi at the hearing scheduled for September 22, 2025, at 1:30 p.m. Eastern Daylight Time in the Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky. Lost City Renewables stated that Mr. Joshi had scheduled out-of-country travel prior to the scheduling order being issued in this matter. The procedural schedule in this case was issued on July 23, 2025, two months before the scheduled September 22, 2025 hearing. The Siting Board notes that this is a shorter timeframe than is typical for Siting Board cases.

The Siting Board, on its own, finds that this notice should be treated as a motion.

The procedural schedule in this matter required motions for substitutions of witnesses to

be filed at least 14 days prior to the scheduled hearing.² The Siting Board reminds the Lost City Renewables that only the Siting Board may excuse or allow substitution of a witness. In this case, the notice, considering it a motion, was timely filed. Based upon the motion and being otherwise sufficiently advised, the Siting Board finds that Lost City Renewables has established good cause to allow David Crouse, P.E., to substitute in place of Sean Joshi in the September 22, 2025 hearing due to Mr. Joshi's international travel and the relatively short timeframe between the procedural schedule and evidentiary hearing in this case.

IT IS THEREFORE ORDERED that Lost City Renewables motion of substitution of David Crouse, P.E., in place of Sean Joshi at the September 22, 2025 hearing is granted.
