## ORDER

On February 24, 2025, Burkesville Gas Company, Inc. (Burkesville) filed its Gas Cost Recovery (GCR) rate report for rates with a proposed effective date of March 28, 2025. Burkesville's previous GCR rate was approved in Case No. 2024-00342.<sup>1</sup>

# LEGAL STANDARD

The Commission's standard of review for GCR rates is well settled as stated in KRS 278.274(1):

In determining whether proposed natural gas utility rates are just and reasonable, the commission shall review the utility's gas purchasing practices. The commission may disallow any costs or rates which are deemed to result from imprudent purchasing practices on the part of the utility.

Further, the utility has the burden to prove the rates are just and reasonable and the Commission may reduce the purchased gas component of the utility's rates, or the rates charged by an affiliated company to the extent the amount is deemed to be unjust or unreasonable.<sup>2</sup>

## DISCUSSION

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that Burkesville's report includes revised rates designed to pass on to its customers its expected change in gas costs. Burkesville's report sets out an Expected Gas Cost (EGC) of \$8.7344 per Mcf, which is an increase of \$0.7315 per Mcf from the previous EGC of \$8.0029 per Mcf. Burkesville's report sets out no Refund Adjustment. Burkesville's current quarter Actual Cost Adjustment of \$0.1848 per Mcf. Burkesville's total ACA is \$0.2299 per Mcf, which is a decrease of \$0.2540 per Mcf from the previous total ACA of \$0.4839 per Mcf.

Based on the calculations above, the Commission finds that Burkesville's GCR rate is \$8.9643 per Mcf, which is an increase of \$0.4775 per Mcf from the previous GCR rate of \$8.4868 per Mcf. The Commission further finds that the rates set forth in the Appendix to this Order are fair, just and reasonable and should be approved for service rendered by Burkesville on and after March 28, 2025.

For the purpose of transparency and to maintain a record of information for future use, the Commission finds that Burkesville shall submit all invoices it receives along with its monthly usage reports for each month of the reporting period when it files its future GCR rate reports. Should Burkesville purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports then the supplier, cost, and amount must be documented in its cover letter to the Commission.

#### IT IS THEREFORE ORDERED that:

1. The rates proposed by Burkesville are denied.

- 2. The rates as corrected by Commission staff and set forth in the Appendix of this Order are approved for service rendered on and after March 28, 2025.
- 3. Burkesville shall submit all invoices it receives along with its monthly usage reports for each month of the reporting period when it files its future GCR rate reports.
- 4. Should Burkesville purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports, then the supplier, cost, and amount shall be documented in its cover letter to the Commission.
- 5. Within 20 days of the date of service of this Order, Burkesville shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
  - This case is closed and removed from the Commission's docket.
