ORDER

A hearing in the above-styled matter was held on Tuesday, March 10, 2026. At the opening of the hearing, East Kentucky Power Corporation, Inc. (EKPC) withdrew its previously filed motion to excuse witness, Jerry Purvis.<sup>1</sup> At the conclusion of the witness testimony, a procedural schedule was established that provided for post-hearing requests for information and briefing.

IT IS THEREFORE ORDERED that:

1. EKPC's motion to excuse witness Jerry Purvis is moot as withdrawn.
2. Post-hearing requests for information, if any, shall be filed on or before March 16, 2026.
3. Responses to post-hearing requests for information shall be filed on or before March 30, 2026.
4. Post-hearing comments of the Attorney General and Sierra Club shall be filed on or before April 13, 2026.
5. EKPC's reply comments shall be filed on or before April 20, 2026.
6. Commission Staff's Report shall be filed on or before June 1, 2026.
