## ORDER

This matter arises on the joint motion of the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General) and Kentucky Industrial Utility Customers (KIUC) filed on August 26, 2025 asking to extend the due date of Lane Kollen's testimony to September 9, 2025.<sup>1</sup> The Commission's June 18, 2025 Order provided that any intervenor testimony be filed no later than August 29, 2025.

The Attorney General and KIUC explained that on August 25, 2025, Kentucky Utilities Company (KU) and Louisville Gas and Electric Company (LG&E) (jointly, LG&E/KU) filed into both cases revisions to their revenue requirements models, supported by multiple new spread sheets.<sup>2</sup> The Attorney General and KIUC's experts have not had any opportunity to submit new data requests based upon this substantial new data, but stated that it is readily apparent that the updated revenue requirement

models will affect the calculations and analyses Mr. Kollen will utilize in drafting his testimony.<sup>3</sup> The Attorney General and KIUC stated that this will require Mr. Kollen to expend additional time and effort to re-work his analyses and calculations, necessitating major revisions to his draft testimony in order to provide the Commission with relevant and coherent testimony based upon the latest data.<sup>4</sup> Counsel for LG&E/KU advised that the companies have no objection to this motion, and had authorized the Attorney General and KIUC to represent such.

Having considered the motion, the Commission finds that the Attorney General and KIUC's request for extension related to their witness Lane Kollen should be granted for good cause shown.

## IT IS THEREFORE ORDERED that:

- 1. The Attorney General and KIUC's motion for extension is granted.
- 2. The testimony of Lane Kollen shall be filed no later than September 9, 2025.
