ORDER

On May 30, 2025 Louisville Gas and Electric Company (LG&E), pursuant to KRS Chapter 278 filed its application for an adjustment of its electric rates and for approval of certain regulatory and accounting treatments.<sup>1</sup>

The Commission, on its own motion, provides notice to all parties that four in-person public comment meetings will be held on the dates and locations listed below for the purpose of receiving public comment on this proceeding. The public comment meetings should be recorded and filed into the case record. The Commission finds that LG&E should ensure that a representative(s) is present at the public comment meetings. The remaining parties are encouraged to provide a representative(s) to the public comment meetings. In addition, LG&E should publish notice of the public meetings in accordance with 807 KAR 5:001, Section 9(2).

In addition to the opportunity to provide public comments at the meeting scheduled in this Order, written public comments may be tendered to the Commission at any time during the consideration of this case. Written public comments should include your name,

1. A local public comment meeting for the purpose of hearing public comments shall be held on September 8, 2025, at 5 p.m. Eastern Daylight Time, at the Jefferson Community & Technical College: Hovarth Auditorium, 1000 Community College Dr., Louisville, KY 40272.
2. A local public comment meeting for the purpose of hearing public comments shall be held on October 13, 2025, at 5 p.m. Central Daylight Time, at the Hopkins County Fiscal Court, 56 North Main Street, Madisonville, KY 42431.
3. A local public comment meeting for the purpose of hearing public comments shall be held on October 14, 2025, at 5 p.m. Eastern Daylight Time at Bluegrass Community & Technical College: Keenland Room, 164 Opportunity Way, Lexington, KY 40511.
4. A local public comment meeting for the purpose of hearing public comments shall be held on October 16, 2025, at 5p.m. Eastern Daylight Time, Middlesboro Community Center, 705 N. Petersborough Ave, Middlesboro, KY 40965.
5. No evidence shall be taken at the local public comment meetings.
6. Recordings of the in person public comment meetings will be filed into the record of this case.

7. LG&E shall provide written notice of the time and place of the local public comment meetings pursuant to 807 KAR 5:001, Section 9(2).
8. Within 20 days after publication, LG&E shall file proof of publication in the file.
9. LG&E shall ensure that a representative(s) is present at the public comment meetings.
