ORDER

On March 27, 2026, the Commission granted Kentucky Utilities Company (KU) and Louisville Gas and Electric Company's (LG&E) (jointly, LG&E/KU) petition for reconsideration. On May 26, 2026, LG&E/KU filed a statement and motion that stated that they do not request a hearing for issues related to the rehearing and requested that the matter be submitted on the written record after the parties are provided an opportunity to submit one round of briefs on the issues presented on reconsideration.¹ LG&E/KU requested the deadline for briefing be set as June 19, 2026.² LG&E/KU also noted that absent approval of the sharing mechanism, they will likely file a new rate case before the end of the year and requested a decision by August 14, 2026.³

1. LG&E/KU's motion for a briefing deadline is granted.
2. All parties may file simultaneous briefs in support of their respective rehearing positions, should they choose to do so, on or before June 19, 2026.
3. This case shall stand submitted for a decision by the Commission effective 12:00 AM Eastern Daylight Time, June 20, 2026.
