## ORDER

A hearing in the above-styled matter was held on Tuesday, September 23, 2025. At the beginning of the hearing, the Commission addressed Kentucky-American Water Company's (Kentucky-American) motion filed on September 22, 2025, to allow witness Robert Mustich to testify virtually, due to an emergency family medical issue that required him to travel out of state. All parties agreed instead to excuse Mr. Mustich from participation at the hearing; thereafter, the Commission, from the bench, excused the witness from the hearing. Therefore, the Commission finds the motion should be denied as moot.

At the conclusion of the witness testimony, a procedural schedule was established that provided for post-hearing requests for information and briefing.

## IT IS THEREFORE ORDERED that:

- 1. Kentucky-American's September 22, 2025 motion is denied as moot.
- 2. Post-hearing requests for information, if any, shall be filed on or before September 29, 2025.
- 3. Responses to post-hearing requests for information shall be filed on or before October 6, 2025.

- 4. Supplemental post-hearing requests for information, if any, shall be filed on or before October 14, 2025.
- 5. Responses to supplemental post-hearing requests for information shall be filed on or before October 21, 2025.
- 6. The parties may, should they so choose file simultaneous memorandum briefs in support of their respective post-hearing positions on or before October 27, 2025.
- 7. This case shall stand submitted for a decision by the Commission effective 12:01 a.m. Eastern Daylight Time, October 28, 2025.
