ORDER

On August 18, 2026, Fleming-Mason Energy Cooperative, Inc. (Fleming-Mason Energy) filed a motion for a deviation from 807 KAR 5:041 Section 7 pursuant to an Order previously issued in Case No. 2025-00131.¹

In support of this request, Fleming-Mason Energy stated its advanced metering infrastructure (AMI) meters are capable of monitoring systemwide voltage and producing on demand readings.² Voltage readings transmitted by the meter are collected in a database and may be exported to a graph, for review by Fleming-Mason Energy personnel, after which point the data is archived for a period of five years.³ These archived records are available for inspection by members and Commission Staff for at least three years in accordance with 807 KAR 5:041 Section 7.⁴ Furthermore, Fleming-

Mason Energy stated it will continue to perform all required meter testing consistent with the Commission's regulations, which will ensure the accuracy of the AMI system.⁵

LEGAL STANDARD

The Commission has exclusive jurisdiction over the regulation of rates and service of utilities in Kentucky.⁶ Pursuant to KRS 278.042, the Commission shall prescribe the service adequacy and safety standards for electric utilities, as stated in the Commission's administrative regulations, Orders, and in the most recent edition of the National Electrical Safety Code (NESC).⁷ In keeping with KRS Chapter 13A, the Commission may adopt reasonable regulations and investigate the methods and practices of utilities to require them to conform to the laws of this state, and to all reasonable rules, regulations and orders of the Commission not contrary to law.⁸ Accordingly, the Commission adopted 807 KAR 5:041 Section 7, of which sets forth rules regarding voltage survey standards. Additionally, in special cases for good cause shown, the Commission may permit deviations from these rules.⁹

DISCUSSION AND FINDINGS

Having reviewed the motion and being otherwise sufficiently advised, the Commission grants Fleming-Mason Energy's motion. The Commission finds that the AMI technology installed will allow for Fleming-Mason Energy to monitor its voltage in a

manner similar to that contemplated by the regulation. The Division of Inspections shall make the final determination as to compliance with the regulation.

IT IS THEREFORE ORDERED that:

1. Fleming-Mason Energy's motion for deviation from voltage survey requirements in 807 KAR 5:041 Section 7 is granted.

2. The Division of Inspections shall make the final determination as to compliance with the regulation.
