### <u>ORDER</u>

On June 2, 2025, North Shelby Water Company (North Shelby Water) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure set forth in KRS 278.012 and 807 KAR 5:068.

### LEGAL STANDARD

In accordance with KRS 278.012, when a wholesale supplier selling water to a water association increases its rates, the water association has the authority to increase its rate commensurate with the wholesale supplier. The water association must file, within the statutory and regulatory deadlines, a copy of the notice from the wholesale supplier showing the increase in the wholesale rate, and a statement of the volume of purchased water used to calculate the rate adjustment. The Commission shall approve the filing by order after the above documents are filed.

### **DISCUSSION AND FINDINGS**

North Shelby Water purchases water from Shelbyville Municipal Water & Sewer Commission (Shelbyville), Louisville Water Company (Louisville), Frankfort Electric and Water Plant Board (Frankfort), and, on an emergency basis only, West Shelby Water District (West Shelby District). Shelbyville notified North Shelby Water that its wholesale rate would increase by \$0.06 per 1,000 gallons from \$2.47 per 1,000 gallons to \$2.53 per 1,000 gallons, effective June 19, 2025.<sup>1</sup> Louisville notified North Shelby Water that its wholesale rate would increase by \$0.07 per 1,000 gallons from \$2.72 per 1,000 gallons to 2.79 per 1,000 gallons,<sup>2</sup> and its monthly service charges would increase by \$6.72 from \$157.95 per 4-inch meter to \$164.67 per 4-inch meter, with both increases effective July 1, 2025.<sup>3</sup> In light of the increase to Louisville's 4-inch meter monthly service charge, it is notable that North Shelby Water has a usage of four, 4-inch meters from Louisville.<sup>4</sup> In response, North Shelby Water proposes to increase the water rates to its customers effective July 1, 2025, to reflect the increased cost of purchased water from Shelbyville and Louisville. Frankfort and West Shelby District did not propose any rate changes.

#### Unaccounted-for Water Loss

Commission regulation 807 KAR 5:066, Section 6(3), states that for ratemaking purposes, a utility's unaccounted-for water loss shall not exceed 15 percent of the total water produced and purchased, excluding water consumed by a utility in its own operations. In its 2024 Annual Report filed with the Commission, North Shelby Water reported a water loss of 11.2268 percent.<sup>5</sup> In its 2023 Annual Report filed with the

Commission, North Shelby Water reported a water loss of 11.2939 percent.<sup>6</sup> In its 2022 Annual Report filed with the Commission, North Shelby Water reported a water loss of 14.4504 percent.<sup>7</sup> North Shelby Water's three-year water loss average is 12.3237 percent.<sup>8</sup>

## **Financial Condition and Rates**

Based on a review of Commission records, North Shelby Water last sought a rate adjustment, filed pursuant to the alternative rate adjustment procedures, in Case No. 2022-00317,<sup>9</sup> which resulted in an increase to North Shelby Water's rates of \$74,956 or 2.18 percent. Based upon a review of the annual and audit reports filed with the Commission, North Shelby Water's rate based income, or adjusted net income minus principal payments, was negative from 2020 through 2022 and was positive for 2023 and 2024. North Shelby Water's cash based income, or rate based income plus depreciation, was positive in all five years. A chart summarizing rate based and cash based income is presented below.

The Commission recommends North Shelby Water continue to monitor its operating performance annually and consider filing future rate cases at least every three to five years, depending on operating performance, to ensure that its revenue is sufficient to support adequate and reliable service.

### Purchased Water Adjustment Factor

In its application, North Shelby Water proposed a purchased water adjustment factor of \$0.08 per 1,000 gallons. During the 12 months ended April 30, 2025, North Shelby Water purchased 131,191,600 gallons of water from Shelbyville, 342,480,000 gallons of water from Louisville, 84,693,580 gallons of water from Frankfort and zero

gallons of water from West Shelby District. North Shelby Water has a usage of four, 4inch, meters from Louisville, equating to an additional increase of \$26.88 per month.<sup>10</sup> North Shelby Water sold 454,483,700 gallons of water to its customers. The increase in the cost of purchased water from Shelbyville and Louisville is \$32,167.66, resulting in a purchased water adjustment factor of \$0.08 per 1,000 gallons. No rate changes occurred from Frankfort or West Shelby District.

The purchased water adjustment factor of \$0.08 per 1,000 gallons, as calculated in Appendix A and the rates as set forth in Appendix B to this Order are fair, just and reasonable and should be approved for water service rendered by North Shelby Water on and after July 1, 2025, because the rates are supported by evidence of the increase in rates from North Shelby Water's wholesale water supplier and the volume of purchased water used to calculate the rates in accordance with KRS 278.012

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment factor of \$0.08 per 1,000 gallons is approved.

2. The rates proposed by North Shelby Water are approved.

3. The rates as set forth in Appendix B to this Order are approved for water service rendered by North Shelby Water on and after July 1, 2025.

4. Within 20 days of the date of service of this Order, North Shelby Water shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.

5. This case is closed and removed from the Commission's docket.
