ORDER


On July 24, 2025, Kentucky Power Company (Kentucky Power) moved the Commission to admit *pro hac vice* Juan Dawson, an attorney whose office is located in Georgia, to practice law before the Commission on behalf of Kentucky Power in association with Katie M. Glass, an attorney licensed to practice law in the Commonwealth of Kentucky, in this case. In support of the request Juan Dawson has shown to be a member in good standing of another state bar and has been certified to practice before the Commission in this case by the Kentucky Bar Association under Kentucky Supreme Court Rule 3.030(2). In addition, Juan Dawson has agreed to be subject to the jurisdiction and rules of the Commission and the Kentucky Bar Association.

IT IS THEREFORE ORDERED that Juan Dawson is admitted *pro hac vice* for the purpose of representing Kentucky Power, in association with Katie M. Glass, in the above-

styled proceeding, provided that Katie M. Glass or another member of the Kentucky Bar Association acts as co-counsel and is present at all proceedings before this Commission.
