3. Counsel for Barrelhead Solar shall file a memorandum brief in support of Barrelhead Solar's post-hearing position on or before February 24, 2026.

4. This case shall stand submitted for a decision by the Siting Board effective 12:01 a.m. Eastern Standard Time, March 4, 2026.


