ORDER

On July 31, 2025, Farmdale Water District (Farmdale District) filed an amended Schedule of Adjusted Operations, amended Schedule of Revenue Requirements, and corrected references in Case No. 2025-00192.¹ This filing was submitted to correct a calculation error in which Miscellaneous Revenues had been improperly included, resulting in an overstatement of the requested increase.² The corrected schedules reduce Farmdale District's requested increase from 23.65 percent to 17.26 percent.³

LEGAL STANDARD

Commission regulation 807 KAR 5:076, Section 8 provides that, except when responding to the findings set forth in a Commission Staff Report filed in accordance with Section 11 of this regulation, an applicant shall not amend the proposed rates set forth in its application unless the applicant:

 Files written notice of the proposed amendment with the Commission; and

 Publishes notice of the amended proposed rates in the manner provided in Section 5 of this regulation.

Further, Section 8(2) provides that an applicant shall not place amended proposed rates into effect until the Commission has issued an order approving those rates or six months from the date of filing of the written notice of the amendment, whichever occurs first.

Commission regulation 807 KAR 5:001, Section 4(5) provides that amendment of an application shall not relate back to the date of the filing of the original application unless the Commission orders otherwise.

DISCUSSION AND FINDINGS

Based on the filings, the Commission finds that Farmdale District's July 31, 2025 filing should be accepted as an amendment to the application pursuant to 807 KAR 5:076, Section 8, and 807 KAR 5:001, Section 4(5). The amendment corrected an error in the revenue requirement calculation, which reduced the requested increase from 23.65 percent to 17.26 percent. As such, the Commission also finds that, because the amendment results in a reduction of the requested increase that a deviation to the additional notice requirements should be grated pursuant to Section 17 of 807 KAR 5:076, as it determined that no additional customer notice is required.

Pursuant to 807 KAR 5:076, Section 8(2), Farmdale District may not place the amended proposed rates into effect until the Commission issues an order approving those rates or six months from the date of the filing of the amendment, whichever occurs first. In accordance with 807 KAR 5:001, Section 4(5), the amendment does not relate back to the date of the original application, and the statutory suspension date resets as of July 31, 2025.

The Commission notes that, at this time, no amendment to the procedural schedule is necessary.

IT IS THEREFORE ORDERED that:

- 1. The amended Schedule of Adjusted Operations, amended Schedule of Revenue Requirements, and corrected references filed by Farmdale District on July 31, 2025, are accepted as an amendment to the application in Case No. 2025-00192.
- 2. A deviation to the additional notice provisions of 807 KAR 5:076, Section 8, is hereby granted.
- 3. Farmdale District shall not place the proposed rates into effect until the Commission issues an Order approving the rates or six months from the date the application was amended, whichever comes first.
- 4. The statutory date is reset to run from July 31, 2025, the date the amendment was filed, and the new statutory date will be May 31, 2026.
- 5. All provisions of the Commission's July 10, 2025 Order that are in conflict with the provisions of this Order are vacated, and all other provisions not in conflict with the provisions of this Order shall remain in effect.
