ORDER

On June 30, 2025, Navitas KY NG, LLC (Navitas KY) filed its quarterly Gas Cost Recovery (GCR) rate report with a proposed effective date of August 1, 2025. Currently, the Commission is reviewing issues surrounding Navitas KY's recent GCR cases, including potential issues with its GCR rate reports.<sup>1</sup> After reviewing the current GCR rate report, the Commission has determined that further investigation and discovery is necessary.

Having reviewed the proposed tariff and being otherwise sufficiently advised, the Commission finds that an investigation is necessary to determine the reasonableness of the proposed GCR rates and that such investigation cannot be completed by August 1, 2025. Pursuant to KRS 278.190(2), the Commission will, therefore, suspend the effective date of the proposed tariff for one day, until August 2, 2025, to give the Commission time to investigate the proposed GCR rates, and to allow Navitas KY to begin charging the GCR rates, pending a final Order and subject to refund, provided it provides written notice to the Commission of its intention to do so pursuant to KRS 278.190(2).

The Commission directs Navitas KY to the Commission's July 22, 2021 Order in Case No. 2020-00085<sup>2</sup> in which the Commission mandated the use of electronic filing procedures listed in 807 KAR 5:001, Section 8. Consistent with the filing procedures set forth in Case No. 2020-00085, the Commission finds that electronic filing procedures should be used.

IT IS THEREFORE ORDERED that:

1. Navitas KY's proposed GCR rates are suspended for one day, to August 2, 2025.


2. Navitas KY's proposed GCR rates August be placed in effect by Navitas KY on, or after August 2, 2025, pending the final Order in this matter and subject to refund, provided Navitas KY files written notice to the Commission of its intention to do so as required by KRS 278.190(2).

3. If Navitas KY files notice of its intention to place the proposed GCR rates into effect after the end of the suspension period, Navitas KY shall maintain its records in such manner as will allow it, the Commission, or any customer to determine the amounts to be refunded and to whom in the event of a refund is ordered upon final resolution of this matter.
