COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION
TO ATMOS ENERGY CORPORATION

Atmos Energy Corporation (Atmos), pursuant to 807 KAR 5:001, shall file with the Commission an electronic version of the following information. The information requested is due on November 3, 2025. The Commission directs Atmos to the Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made and shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the

response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Atmos shall make timely amendment to any prior response if Atmos obtains information that indicates the response was incorrect or incomplete when made or, though correct or complete when made, is now incorrect or incomplete in any material respect.

For any request to which Atmos fails or refuses to furnish all or part of the requested information, Atmos shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied and scanned material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Atmos shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Provide the expected federal tax expense or loss, on a standalone basis, for Atmos's operations for the years ending September 30, 2025, and September 30, 2026, including all revenue and expenses for regulated operations but excluding operating losses carried forward or backward from other years, and provide all work papers showing how the expected tax expense was calculated in each year in Excel spreadsheet format with all formulas, rows, and columns fully accessible and unprotected.

2. Identify the dollar amount of all capital projects allocated to Atmos's Kentucky operations and included as an addition to plant in service for Atmos's Kentucky operations in each of the fiscal years ending September 30, 2023, September 30, 2024, and September 30, 2025.

3. Identify the total change in federal deferred tax liabilities, whether an increase or decrease, from Atmos's Kentucky operation in the fiscal year ending September 30, 2025, and provide all work papers showing how the change in deferred tax liabilities was calculated in Excel spreadsheet format with all formulas, rows, and columns fully accessible, intact, and unprotected.

4. Identify all projected capital expenditures for Atmos's Kentucky operations in the fiscal year ending September 30, 2026.

5. Refer to the application, Exhibit F. Explain whether Atmos Energy's FXA02 balances are for the Kentucky division only.

6. Refer to the application, Exhibit B-1.

a. Provide a detailed financial analysis demonstrating that Atmos's Kentucky operations actually generated the Net Operating Loss Carryforward (NOLC) Accumulated Deferred Income Tax (ADIT) during the periods relevant to the Pipeline Replacement Program (PRP) investments.

b. Explain how Atmos Energy allocates the NOLC Deferred Tax Asset (DTA) from its consolidated federal tax return to the Kentucky division.

7. Provide a revised PRP rate calculation that assumes no unprotected NOLC DTA adjustment. Provide this response in Excel spreadsheet format with all formulas, rows, and columns fully accessible, intact, and unprotected.
