ORDER

On October 13, 2025, Kentucky Power Company (Kentucky Power) filed a motion to deviate, pursuant to 807 KAR 5:001, Section 22, seeking approval to present the Commission with a USB drive containing the responses to Appalachian Citizens' Law Center, Kentuckians for the Commonwealth, Kentucky Solar Energy Society, and Mountain Association's (collectively, Joint Intervenors) First Request for Information, Item 29, Item 54, and Item 62.¹ Kentucky Power explained the documents exceed the current 50 MB per-file filing limit of the Commission's E-Filing System and the documents are not able to be broken into smaller files, as doing so would disrupt formulas in the Excel spreadsheets.² For the reasons stated below, the Commission grants Kentucky Power's motion to deviate.

LEGAL STANDARD

Pursuant to 807 KAR 5:001, Section 22, the Commission may, at its discretion, allow deviation from the filing requirements in 807 KAR 5:001 upon a showing of good cause. Commission regulation 807 KAR 5:001, Section 8 and Case No. 2020-00085³ require parties to cases such as this proceeding to electronically upload all filings to the Commission's electronic filing system.

KENTUCKY POWER'S MOTION TO DEVIATE

Kentucky Power's motion to deviate stated that three voluminous attachments titled: Attachment 1 to JI 1-29, Attachment 1 to JI 1-54, and Attachment 1 to JI 1-62 exceed the 50 MB filing limit of the Commission's E-Filing System.⁴ Additionally, Kentucky Power stated it consulted with and was instructed by Commission Staff regarding the requested filing procedure given the voluminous content of the identified attachments.⁵ Kentucky Power stated in its motion that the USB drive will be mailed via overnight delivery to the Commission's office and should be received by October 15, 2025, and uploaded the attachments to the Commission's internal document management system.⁶

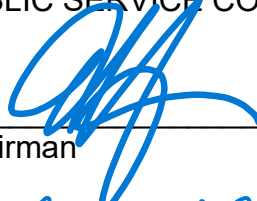
DISCUSSION AND FINDINGS

Based upon a review of the motion, and being otherwise sufficiently advised, the Commission finds that Kentucky Power has established good cause to deviate from the filing requirements housed in 807 KAR 5:001, Section 8. By providing the Commission with a USB drive, the Commission is able to maintain its records in accordance with KRS 278.100. Additionally, Kentucky Power is instructed to provide identical USB drives to all parties granted intervention in this case, if requested by the parties.

IT IS THEREFORE ORDERED that:

1. Kentucky Power's motion to deviate from 807 KAR 5:001, Section 8, is granted.
2. Kentucky Power is instructed to provide a copy of the subject materials to all parties to this matter on a physical USB drive, if requested.
