## ORDER

On November 18, 2025, the Attorney General of the Commonwealth of Kentucky, through the Office of Rate Intervention (Attorney General) and Kentucky Industrial Utility Customers, Inc. (KIUC) (jointly, Movants) filed a motion for their witness, Richard Baudino, to appear virtually at the January 13, 2026 hearing in this matter. In support of the motion, Movants stated that Mr. Baudino is the primary caretaker for a family member with long term health care needs. According to the motion, if Mr. Baudino was required to appear in person at a hearing, it would create a hardship for the family.

Having considered the motion and facts, the Commission finds good cause to grant the motion. Providing the primary care for a family member with long term care needs is good cause to allow Mr. Baudino to testify remotely. The Movants were proactive in this

request and all parties had sufficient time to respond to the matter as provided for in 807 KAR 5:001, Section 5(2). Mr. Baudino should be authorized to participate virtually at the hearing on January 13, 2026. Commission Staff shall coordinate with counsel prior to the hearing to ensure that the witness is provided a link for remote participation.

## IT IS THEREFORE ORDERED that:

- 1. The motion is granted.
- 2. Mr. Baudino is authorized to participate virtually at the January 13, 2026 hearing, an any date thereafter, so long as the hearing is continued.
- 3. Commission Staff shall coordinate with the parties to ensure Mr. Baudino is provided a link for remote participation.
