ORDER

On November 18, 2025, Kentucky Solar Industries Association, Inc. (KYSEIA) filed a motion for its witness, Justin R. Barnes, to appear virtually at the January 13, 2026 hearing in this matter.¹ In support of the motion, KYSEIA stated that Mr. Barnes is scheduled to address matters pertaining to his family during the week of January 13, 2026, necessitated by developments outside of his control, and is unable to travel.²

Having considered the motion and facts, the Commission finds good cause to grant the motion. Unavailability to travel due to family matters is good cause to allow Mr. Barnes to testify remotely. KYSEIA was proactive in this request and all parties had sufficient time to respond to the matter as provided for in 807 KAR 5:001, Section 5(2). Mr. Barnes should be authorized to participate virtually at the January 13, 2026. Commission Staff

- 2. Mr. Barnes is authorized to participate virtually at the January 13, 2026 hearing, and any date thereafter, so long as the hearing is continued.
- 3. Commission Staff shall coordinate with the parties to ensure Mr. Barnes provided a link for remote participation.
