O R D E R

A hearing in the above-styled matter was held on Tuesday, February 3, 2026. Prior to the taking of evidence, counsel for Kentucky Frontier Gas, LLC (Kentucky Frontier) indicated that the rebuttal and corrected rebuttal filing reflected the applicant's position after evidence from the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention, and not an amendment of the application. In addition, Commission regulation 807 KAR 5:076, Section 12(4), states, "at least 14 days **prior**" (emphasis added) to the hearing date, notice of the hearing date shall be given. Notice of this hearing was mailed to customers 13 days prior to the hearing date. Consequently, the notice did not technically comply with the regulation, but pursuant to the information of record, the Commission finds that Kentucky Frontier substantially complied with the notice requirement. As such, the Commission, on its own motion, grants a deviation from the regulation for good cause. The Commission recognizes that the mailing was in substantial compliance with the regulation, and customers were aware of the ability to make public comments because there were at least three in the record.¹


At the conclusion of the witness testimony, a procedural schedule was established that provided for post-hearing requests for information and briefing.

IT IS THEREFORE ORDERED that:

1. The Commission, on its own motion, grants a deviation from 807 KAR 5:076 Section 12(4).
2. Post-hearing requests for information, if any, shall be filed on or before February 6, 2026.
3. Responses to post-hearing requests for information shall be filed on or before February 16, 2026.
4. Should they so choose, the parties shall file an initial memorandum brief in support of its post-hearing position on or before February 20, 2026.
5. Should they so choose, the parties shall file a memorandum in response to the initial brief, limited solely to issues raised in the initial briefs on or before February 27, 2026.
6. This case shall stand submitted for a decision by the Commission effective 12:01 a.m. Eastern Standard Time, February 28, 2026.
