ORDER

On September 16, 2025, Kentucky Power Company (Kentucky Power) filed a motion requesting that the Commission schedule an informal conference for the purpose of discussing the aspects of Kentucky Power's application, or to discuss any other matters that may aid Commission Staff in the handling and disposition of the case.¹

Based upon the motion, the Commission finds that an informal conference may be beneficial, and therefore the motion should be granted. 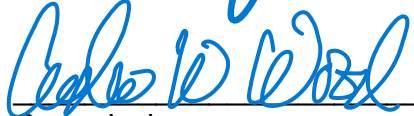

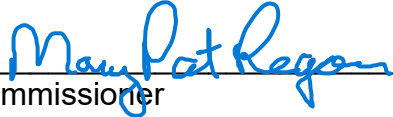
3. Commission Staff will contact participants by electronic mail to provide details for the option of joining the conference by video link.
