## ORDER

On September 5, 2025, Kentucky Power Company (Kentucky Power) filed an application for approval to establish a regulatory asset for extraordinary storm costs. On September 22, 2025, Commission Staff issued its First Request for Information (Staff's First Request) with a response due date of September 30, 2025.

On September 23, 2025, Kentucky Power filed a motion for an extension of time to respond to Staff's First Request. In its motion, Kentucky Power requested one additional day to file its responses, citing traveling to its informal technical conference with Commission Staff on September 30, 2025, and aligning the due date with Staff's Request in Kentucky Power's other storm damage regulatory asset request in Case No. 2025-00264.<sup>1</sup> The request would make responses due on October 1, 2025.
