## COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION TO ROWAN WATER, INC.

Rowan Water, Inc. (Rowan Water), pursuant to 807 KAR 5:001, shall file with the Commission an electronic version of the following information. The information requested is due on October 6, 2025. The Commission directs Rowan Water to the Commission's July 22, 2021 Order in Case No. 2020-00085<sup>1</sup> regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made and shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the

response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Rowan Water shall make timely amendment to any prior response if Rowan Water obtains information that indicates the response was incorrect or incomplete when made or, though correct or complete when made, is now incorrect or incomplete in any material respect.

For any request to which Rowan Water fails or refuses to furnish all or part of the requested information, Rowan Water shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied and scanned material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filling a paper containing personal information, Rowan Water shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

- Refer to the Purchased Water Adjustment Application submitted by Rowan
  Water on September 11, 2025.
- a. Provide the monthly statements of gallons purchased by Rowan Water from its supplier during the 12-month period ending August 1, 2025.
- b. Explain the large discrepancy between Rowan Water's total gallons purchased, and the total gallons sold during the 12 months ending August 1, 2025.

2. Refer to the 2024 Annual Report<sup>2</sup> filed by Rowan Water, Water Statistics,

page 30.

a. Provide the monthly System Flushing records for calendar year 2024

and year to date 2025.

b. Explain why Rowan Water recorded flushing 204,406,000 gallons,

which is an increase from 166,144,000 in 2023.

3. Refer to the 2024 Annual Report filed by Rowan Water. Reconcile the

decrease in the number of residential customers for 2024 with the increase in residential

gallons sold.

4. Refer to the 2024 Annual Report filed by Rowan Water, specifically Sales

for Resale (466), which lists 28,030,000 gallons and \$348,445 revenue. Reconcile these

amounts to Rowan Water's wholesale rate schedule differentials shown in Exhibit C,

submitted with the Application, and provide the calculations for each per 1,000 gallons.
