ORDER

On October 2, 2025, Hardin County Water District #1 (Hardin District #1) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure set forth in KRS 278.015 and 807 KAR 5:068. On October 27, 2025, Hardin District #1 submitted additional information into the case file.

LEGAL STANDARD

In accordance with KRS 278.015, when a wholesale supplier selling water to a water district increases its rates, the water district has the authority to increase its rate commensurate with the wholesale supplier. The water district must file, within the statutory and regulatory deadlines, a copy of the notice from the wholesale supplier showing the increase in the wholesale rate, and a statement of the volume of purchased water used to calculate the rate adjustment. The Commission shall approve the filing by order after the above documents are filed.

DISCUSSION AND FINDINGS

Hardin District #1 produces a portion of its own water. However, Hardin District #1 also purchases water from Hardin County Water District #2 (Hardin District #2), Louisville Water Company (Louisville Water), and U.S. Treasury Garrison Resource Management

(U.S. Treasury Garrison). Hardin District #2 notified Hardin District #1 that its wholesale rate would increase by \$0.02 per 1,000 gallons from \$2.89 per 1,000 gallons to \$2.91 per 1,000 gallons, effective July 1, 2025. Louisville Water notified Hardin District #1 that its wholesale rate would increase by \$0.07 per 1,000 gallons from \$2.72 to \$2.79, and its monthly service charge would increase by a total of \$6.72, from \$157.95 to \$164.67, effective July 1, 2025. Hardin District #1 proposes to increase the water rates to its customers effective October 30, 2025, to reflect the increased cost of purchased water from Hardin District #2 and Louisville Water. No rate changes occurred from U.S. Treasury Garrison.

Unaccounted-for Water Loss

Commission regulation 807 KAR 5:066, Section 6(3), states that for ratemaking purposes a utility's unaccounted-for water loss shall not exceed 15 percent of the total water produced and purchased, excluding water consumed by a utility in its own operations. In its 2022 Annual Report filed with the Commission, Hardin District #1 reported a water loss of 5.0326 percent.⁵ In its 2023 Annual Report filed with the

Commission, Hardin District #1 reported a water loss of 2.8211 percent.⁶ In its 2024 Annual Report filed with the Commission, Hardin District #1 reported a water loss of 2.7647 percent.⁷ Hardin District #1's three-year water loss average is 3.5395 percent.⁸ The cost of Hardin District #1's total water loss using a three-year average is approximately \$27,854.19.⁹

Financial Condition and Rates

In Case No. 2019-00041, the Commission discussed the problems that can occur when utilities intentionally avoid a review of their financial records by relying solely on financing cases to increase rates. A key recommendation from that proceeding was that water districts should monitor the sufficiency of their base rates closely and, in general, apply for base rate adjustments on a more frequent basis. Based on a review of Commission records, Hardin District #1 has not sought a general base rate adjustment since 2006. Hardin District #1's last rate adjustment resulted from an application for a Certificate of Public Convenience and Necessity (CPCN) and federal financing approval in accordance with KRS 278.023, in Case No. 2022-00337, which increased rates by

41.2 percent.¹³ In accordance with the provisions of KRS 278.023, the Commission's review of such applications is a limited review of a utility's total financial stability and operational viability. Hardin District #1 has also adjusted its rates by filing several purchased water adjustment (PWA) applications since the last general rate case.

Based upon a review of the annual and audit reports filed with the Commission, Hardin District #1's rate-based income, adjusted net income minus principal payments, was negative in 2020 and positive from 2021 through 2024. Cash basis income, rate-based income plus depreciation, was positive from 2020 through 2024. A chart summarizing cash basis and rate-based income is presented below.

The Commission finds that Hardin District #1 should monitor its operating performance and file a rate case no less than every three to five years, depending on operating performance, to ensure that its revenue is sufficient to support adequate and reliable service.

Purchased Water Adjustment Factor

In its application, Hardin District #1 proposed a purchased water adjustment factor of \$0.01 per 1,000 gallons.¹⁴ During the 12 months ended August 31, 2025, Hardin

District #1 purchased 149,062,000 gallons of water from Hardin District #2, 125,610,000 gallons of water from Louisville Water, and 815,000 gallons of water from U.S. Treasury Garrison. During the same 12 month period, Hardin District #1 produced 1,087,278,128 gallons of water and sold 1,219,377,236 gallons of water to its customers. The increase in the cost of purchased water from Hardin District #2 and Louisville Water is \$11,773.94, resulting in a purchased water adjustment factor of \$0.01 per 1,000 gallons. No rate changes occurred from U.S. Treasury Garrison.

The purchased water adjustment factor of \$0.01 per 1,000 gallons, as calculated in Appendix A and the rates as set forth in Appendix B to this Order are fair, just and reasonable and should be approved for water service rendered by Hardin District #1 on and after October 30, 2025, because the rates are supported by evidence of the increase in rates from Hardin District #1's wholesale water supplier and the volume of purchased water used to calculate the rates in accordance with KRS 278.015.

IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment factor of \$0.01 per 1,000 gallons is approved.
 - 2. The rates proposed by Hardin District #1 are approved.
- 3. The rates as set forth in Appendix B to this Order are approved for water service rendered by Hardin District #1 on and after October 30, 2025.
