ORDER

On July 2, 2026, the Commission issued a final Order in this matter.¹ Grayson County Water District (Grayson District) and Edmonson County Water District (Edmonson District) (collectively, Joint Applicants) subsequently filed a joint motion for rehearing on July 21, 2026.² By Order entered on August 6, 2026, the Commission granted rehearing for the limited purpose of developing the evidentiary record concerning the proposed transfer of assets.³

Therefore, the Commission, on its own motion, finds that a procedural schedule for rehearing should be established for the orderly processing of this case. The procedural schedule is attached as an Appendix to this Order.

2. Joint Applicants shall respond to all requests for information propounded by Commission Staff, whether identified on the procedural schedule or otherwise, as provided in those requests.
3. The Commission does not look favorably upon motions for continuance. Accordingly, motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.

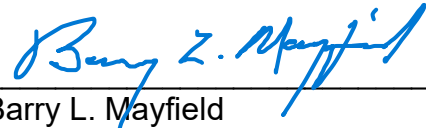
