ORDER

On December 12, 2025, Navitas KY NG, LLC (Navitas KY) filed its responses to Commission Staff's Post-Hearing Requests for Information (Staff's Post-Hearing Request).<sup>1</sup> On December 17, 2025, Navitas KY filed supplemental responses, along with a motion for leave for the late filed responses (Motion).<sup>2</sup>

On December 12, 2025, Navitas KY submitted complete responses to nearly all of Staff's Post-Hearing Requests. Navitas KY stated that despite diligent efforts, it was unable to provide complete responses to all 29 requests by the deadline due to time constraints.<sup>3</sup> Navitas KY stated that, during the hearing, the Commission acknowledged the short turnaround for responding to Staff's Post-Hearing Requests and indicated that if Navitas KY were unable to provide responses by the deadline, then Navitas KY may supplement its responses, as needed, after December 12, 2025.<sup>4</sup>

Having considered the record and being otherwise sufficiently advised, the Commission finds that Navitas KY's Motion should be granted. The Commission acknowledges that due to the emergency nature of Navitas KY's requested rate increase, that the responses to the requests for information required a quick turnaround.<sup>5</sup> Therefore, the Commission believes that there is good cause to allow the filing of supplemental responses on December 17, 2025.

IT IS THEREFORE ORDERED that Navitas KY's Motion is granted.
