O R D E R

On November 18, 2025,<sup>1</sup> Navitas KY NG, LLC (Navitas KY) filed its application with the Commission requesting to adjust its water rates pursuant to 807 KAR 5:076. After a hearing, the Commission issued an Order granting an emergency rate increase, subject to refund.<sup>2</sup> However, the Commission must continue its investigation of the requested increase.

The Commission finds that a procedural schedule<sup>3</sup> should be established to ensure the orderly review of Navitas KY's application. The procedural schedule is attached as an Appendix to this Order.

IT IS THEREFORE ORDERED that:

1. The procedural schedule set forth in the Appendix to this Order shall be followed.

<sup>3</sup> No action is necessary to suspend the effective date of Navitas KY's proposed rates for service. Pursuant to 807 KAR 5:076, Section 7(1), an applicant who applies for a rate adjustment pursuant to the procedures set for in 807 KAR 5:076 may not place its proposed rates into effect until the Commission approves those rates or six months from the date of the filing of its application.

2. Navitas KY shall respond to all requests for information propounded by Commission Staff (Staff), whether identified on the procedural schedule or otherwise, as provided in those requests.

3. No later than the date set forth in the procedural schedule, Staff shall file with the Commission and serve upon all parties of record a written report (Staff Report) containing its recommendations regarding Navitas KY's requested rate adjustment.

4. No later than 14 days after the date of service of the Staff Report, each party of record shall file with the Commission:

a. Its written comments on and any objections to the findings and recommendations contained in the Staff Report; and

b. Any additional evidence for the Commission to consider.

5. If Staff finds that Navitas KY's financial condition supports a higher rate than Navitas KY proposes or the assessment of an additional rate or charge not proposed in Navitas KY's application, Navitas KY in its response to the Staff Report shall also state its position in writing on whether the Commission should authorize the assessment of the higher rate or the additional rate or charge.

6. If Staff finds that changes should be made to the manner in which Navitas KY accounts for the depreciation of Navitas KY's assets, Navitas KY in its response to the Staff Report, Navitas KY shall also state its position in writing on whether the Commission should require Navitas KY to implement the proposed change for accounting purposes.

7. A party's failure to file written objections to a finding or recommendation contained in the Staff Report within 14 days after the date of the service of the Staff Report shall be deemed a waiver of all objections to that finding or recommendation.

8. If a party requests a hearing or informal conference, then the party shall make the request in its written comments and state the reason a hearing or informal conference is necessary.

9. A party's failure to request a hearing or informal conference in the party's written response shall be deemed a waiver of all rights to a hearing on the application and a request that the case stand submitted for decision.

10. A party's failure to file a written response within 14 days after the date of service of the Staff Report shall be deemed a waiver of all rights to a hearing on the application.

11. As set forth in 807 KAR 5:001, Section 4(11), a person requesting permissive intervention in a Commission proceeding is required to demonstrate either (1) a special interest in the proceeding that is not adequately represented in the case, or (2) that intervention is likely to present issues or develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. Therefore, any person requesting to intervene in a Commission proceeding must state with specificity the person's special interest that is not otherwise adequately represented or the issues and facts the person will present that will assist the Commission in fully considering the matter. A mere recitation of the quantity of the utility consumed by the movant or a general statement regarding a potential impact of possible modification of rates will not be deemed sufficient to establish a special interest.


12. Any motion to intervene filed after the date established in the procedural schedule attached as an Appendix to this Order shall also show good cause for being untimely. If the untimely motion is granted, the movant shall accept and abide by the existing procedural schedule.

13. The Commission directs the parties to the Commission's July 22, 2021 Order in Case No. 2020-00085<sup>4</sup> regarding filings with the Commission.
