O R D E R

On January 28, 2026, the Commission issued an Order in this matter establishing a procedural schedule and ordering a hearing in this matter. The Order incorrectly set the hearing date for April 28, 2026 instead of April 29, 2026.

HEREBY ORDERS, *nunc pro tunc*, that:

1. Ordering paragraph 4 is stricken and is replaced with the following language:

A hearing in this matter shall be held on April 29, 2026, at 9 a.m. Eastern Daylight Time and continue until called from the bench by the presiding officer, in the Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.

2. The hearing date language provided in the Procedural Schedule, Appendix A, is stricken and replaced with the following:

3. All other provisions of the Commission's January 28, 2026 Order that are not in conflict with the terms of this Order shall remain in effect.
