ORDER

On May 21, 2026, MYSO, LLC (MYSO) filed a motion to substitute Matthew Batdorf as a witness for Jessica Hodges in the hearing scheduled for June 10, 2026, at 9 a.m. Eastern Daylight Time in the Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky. MYSO stated that Ms. Hodges was mistakenly listed as the sponsoring witness for Siting Board Staff's First Request for Information, Item 12 and Item 49 to instead of Mr. Batdorf.¹ MYSO stated that Mr. Batdorf is a Natural Resources and Planning Manager at Tera Tech and is qualified and prepared to adopt Ms. Hodges' responses.²

Based upon the motion and being otherwise sufficiently advised, the Siting Board finds that MYSO, LLC has established good cause to allow Matthew Batdorf to substitute as MYSO's witness in place of Jessica Hodges at the June 10, 2026, hearing scheduled in this case.




