COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION
TO ATMOS ENERGY CORPORATION

Atmos Energy Corporation (Atmos), pursuant to 807 KAR 5:001, shall file with the Commission an electronic version of the following information. The information requested is due on January 21, 2026. The Commission directs Atmos to the Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made and shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the

response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Atmos shall make timely amendment to any prior response if Atmos obtains information that indicates the response was incorrect or incomplete when made or, though correct or complete when made, is now incorrect or incomplete in any material respect.

For any request to which Atmos fails or refuses to furnish all or part of the requested information, Atmos shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied and scanned material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Atmos shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Refer to Atmos's Gas Cost Adjustment (GCA) rate report filing for the period February 1, 2026, to April 30, 2026, Exhibit E, Performance Based Rate Recovery Factor (PBRRF) Calculation sheets. Provide supporting documentation to justify the information presented along with a monthly breakdown of the costs or savings for each component of the PBRRF along with information regarding the benchmarks used and the costs associated with the gas costs used against such benchmarks. Provide these responses

in a version in PDF format and a version in Excel spreadsheet format, with all formulas, columns, and rows unprotected and fully accessible.

2. Refer to Atmos's GCA rate report filing for the period February 1, 2026, to April 30, 2026, Exhibit E, PBRRF Calculation. Provide breakdown of PBRRF summary schedule for the period of June 1, 2024, to January 31, 2024, and February 1, 2024, to January 31, 2025.
