ORDER

On May 6, 2025, Cannonsburg Water District (Cannonsburg District) filed its application for a Certificate of Public Convenience and Necessity (CPCN) and financing for the Shopes Creek Road area system improvements. Within the application, Cannonsburg District requested that its water loss surcharge case, Case No. 2014-00267,¹ be incorporated into the case record of this matter, Case No. 2025-00020.²

As part of the application in Case No. 2025-00020, Cannonsburg District proposed financing the Shopes Creek Road area water system improvements project with Cleaner Water Program grant funds from two grants, a Kentucky Infrastructure Authority (KIA) loan, and the remaining funds from Cannonsburg District's water loss reduction surcharge.³ Cannonsburg District has approximately \$484,196 remaining in the

surcharge account and has submitted a corresponding request in the surcharge case to use the funds to finance the proposed project.⁴

Pursuant to 807 KAR 5:001, Section 11(5), the Commission may incorporate the record of a case in the Commission's files or documents on file with the Commission and may be made a part of the record by reference only. Here, in order to adequately address the proposed projects and financing, it is important to review and reference both matters. Accordingly, the Commission finds that incorporation by reference of Case No. 2014-00267 case record, as it stands as of May 6, 2025, will provide a more complete review.

IT IS THEREFORE ORDERED that the case record of Case No. 2014-00267, as of the filings tendered on or before May 6, 2025, is incorporated by reference into the record of this proceeding.


