RE: Informal Conference of October 30, 2025

Pursuant to Commission Staff's Notice issued on September 29, 2025, a second Informal Conference was conducted on October 30, 2025. Attached is a copy of the attendance roster.

The purpose of the second Informal Conference was to follow up on a possible onsite visit discussed during the first Informal Conference conducted on August 18, 2025, arising from a complaint filed by Larry and Debra Peterman against Kentucky Power Company (Kentucky Power) on December 6, 2024, concerning stray voltage in and around the Petermans' pool.

Kentucky Power advised they increased the scope of testing that had been performed during prior on-site visits to the Petermans' house in September and November of 2024, by conducting drive around testing, and installing additional ground wires with no noticeable change. Kentucky Power stated that all voltage readings were consistent with previous findings.

The prior disconnect between the Petermans and Kentucky Power concerning exactly what tests had been conducted and the final interpretation of those results appeared to have been resolved, with Kentucky Power stating that the data indicated a bonding issue with the pool, and the Petermans taking steps to reinforce and correct the bonding of the pool.

Both parties agreed to remain in contact concerning the issue, but agreed that the re-bonding of the pool couldn't be verified with voltage readings until spring.

There being no further discussion, the IC was then adjourned.
