MARCAUX FARM DISPUTES GETTING BILLED FOR AN ESTIMATED BILL BASED ON THE PREVIOUS YEARS USAGE DUE TO A MALFUNCTION OF THEIR METER WHEN WE HAD A SUBSTANTIALLY REDUCED NUMBER OF HORSES THEREFORE LESS WATER USED THAN IN PREVIOUS YEARS
