NORTH SHELBY WATER COMPANY'S ANSER TO THE COMPLAINT OF KEVIN HEATH COPENAHAVER

Comes North Shelby Water Company, in by counsel, and in Answer to the Complaint of Kevin Heath Copenhaver, states as follows:

- 1. North Shelby Water Company denies that the initial late fee charged against Mr. Copenhaver was incorrectly charged. The payment mailed by Mr. Copenhaver was not received by North Shelby Water Company until after it was due. The ten percent late charge is from North Shelby Water Company's tariff and was correctly applied. While North Shelby Water Company is sympathetic to Mr. Copenhaver, it offers its customers multiple options to pay their bill, including online. Mr. Copenhaver chose to pay by mail. After making his payment, he was aware of the weather conditions and should have been aware of the delays in the mail that have frequently occurred over the last few years. Mr. Copenhaver should have to pay the \$10.87 late fee penalty for his late payment in January 2025.
- 2. Having reviewed KAR 5:0006, Section 9(3)(h)(3), North Shelby Water Company agrees that "additional late payment charges shall not be assessed on unpaid late payment charges"

and will remove any such additional late payment charges from Mr. Copenhaver's account.

WHEREFORE, North Shelby Water Company requests that the Commission dismiss Mr.

Copenhaver's Complaint.
