- 1. I am the office manager for North Shelby Water Company.
- 2. On Thursday September 18, 2025, I was contacted by Nathan T. Riggs, attorney for North Shelby Water Company. Mr. Riggs asked me to remove all late fees except the original late fee from Mr. Copenhaver's account.
- 3. I stated to Mr. Riggs that I had previously explained to Mr. Copenhaver that our computer system made it difficult to stop charging late fees. Our system automatically charges late fees when there is a balance on the account, which is why he was being charged late fees on the current bill.
