RE: Informal Conference of January 23, 2026.

Pursuant to an Order issued on January 21, 2026, an informal conference (IC) was conducted on January 23, 2026. Attached is a copy of the attendance roster.

The IC was requested by Graves County Water District (Graves County District). The purpose of the IC was to discuss the issues raised in the motion for rehearing filed in Case No. 2025-00060 on January 15, 2026.

Amanda Lawson started the meeting stating that staff could not speak for the Commission, and that the meeting was to only discuss Case No. 2025-0060 and Case No. 2019-00347. All participants introduced themselves and the representative of Graves County District, Gerald Wuetcher, was invited to speak.

Gerald Wuetcher discussed the issues presented in the Motion for Rehearing filed in Case No. 2025-00060 on January 15, 2026, which included the notice requirement of tap fees and compared them to other Commission added fees. Mr. Wuetcher then discussed the water loss surcharge outlining his reasoning for the motion for rehearing on the issue, and their concerns for the legal issues it may cause if they file a motion and are granted the water loss surcharge in Case No. 2019-00347.

There being no further discussion, the IC was then adjourned.
