As the Chair of the Kentucky Public Service Commission (PSC), I also serve as the Chair of the Kentucky State Board on Electric Generation and Transmission Siting (Siting Board). Therefore, it is my duty to inform you that, on March 14, 2025, the Siting Board received a Notice of Intent from Summer Shade Solar, LLC requesting a certificate to construct an approximately 106-megawatt merchant electric solar generation facility in Metcalfe County, Kentucky.

- b. The proposed construction is briefly described as follows:

The facility will be located on approximately 737 acres inside fencing and consist of solar panels and associated racking (approximately 106 MW), inverters, electric equipment, project substation and transformer, utility switching station, transmission line, underground electrical connection lines, and a battery storage system and related equipment.

- c. The proposed Summer Shade Project will be located to the west of State Highway 163 (KY-163) and near Summer Shade Road and Apple Grove Road. The latitude and longitude are approximately 36°51'25"N, 85°41'45"W. The Summer Shade Project is not located within the limits of any city. It will be located in Metcalfe County.
- d. There is no planning commission with jurisdiction over this site.
- e. There are no setback requirements established by a planning and zoning commission.
- f. There are no schools, hospitals, or nursing home facilities within 2,000 feet of the project. Nevertheless, there are a few residential neighborhoods within 2,000 feet of the project. Accordingly, the applicant will request a deviation from the setback requirements found in KRS 278.704(2).
