Pursuant to 807 KAR 5:011, Section 8, Salt River Electric Cooperative Corporation ("Salt River") gives notice to its members that it has requested that the Kentucky Public Service Commission ("Commission") allow it to modify the tariff narrative contained within the cooperative's Outdoor Lighting Schedule - OL.

Proposed Modification to Outdoor and Commercial Lighting Schedule

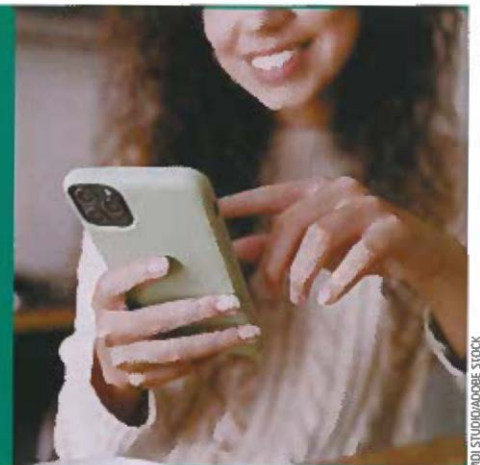
Due to supplies no longer being available for current outdoor and commercial lighting offerings, the cooperative is proposing a change to LED lights only once replacement is necessary. Once replacement is necessary, the customer's outdoor lighting service will be moved to Schedule LED, LED Outdoor Lighting. Additionally, the cooperative proposes to delete the Commercial Lighting Schedule - CL.

The modified tariff will be submitted to the Commission no later than March 1. If approved by the Commission, the new tariff will become effective March 31. The change contained in the tariff filing, and in this notice, is proposed by Salt River. The Commission may order a revision or rates that differs from the proposed changes contained in this notice.

A person may examine Salt River's tariff filing, and any related documents, at the Commission's offices located at 211 Sower Boulevard, Frankfort, Kentucky 40602, Monday through Friday, 8 a.m. to 4:30 p.m. or through the Commission's website at <http://psc.ky.gov>. A person may also view the tariff filing and related documents at Salt River's main office located at 111 West Brashear Ave., Bardstown, KY 40004.

Comments regarding the tariff filing may be submitted to the Commission through its website at <http://psc.ky.gov>, or by mail to the Public Service Commission, P.O. Box 615, Frankfort, KY 40602. Also at this mailing address, a person may submit to the Commission a timely written request for intervention establishing the grounds for the request including the status and interest of the party. If the Commission does not receive a written request for intervention within thirty (30) days of the date of this publication, the Commission may take final action on the tariff filing.

Service under this schedule is for a term of not less than one year and is subject to rules and regulations of the seller as approved by the Kentucky Public Service Commission.

OUTDOOR LIGHTING SCHEDULE OL (Cont.)

SPECIAL TERMS AND CONDITIONS OF SERVICE:

1. **Company will furnish and install the lighting unit complete with lamp fixture or lumina, control device, and mast arm. The above rates for overhead service contemplate installation on an existing wood pole with service supplied from overhead circuits only. For underground decorative lights, the above rates assume that the light will be in an underground subdivision.**
2. **Service required other than the above shall be paid for, by the customer according to the initial cost of labor and material required for such installation.**
3. **Once Lamp replacement is necessary, Lamp supply has become obsolete and will no longer be furnished and made available by the Cooperative, Customers shall move to current supplied lighting/lamp replacement. The Cooperative will not furnish or make available in cases of vandalism or willful destruction. All service and maintenance will be performed during normal working hours.**
