**INTRA-AGENCY MEMORANDUM
KENTUCKY PUBLIC SERVICE COMMISSION**

RE: Informal Conference of January 6, 2026

Pursuant to an Order issued on January 5, 2026, a virtual informal conference (IC) was held and representatives of North Marshall Water District (North Marshall District) participated in the virtual conference with Commission Staff. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss an error identified in the Staff Report that, if corrected, would increase the revenue requirement recommended by Staff in the report. At the IC, Staff initially noted that while Staff could discuss issue at the IC that Staff did not speak for the Commission, which only speaks through its orders. Staff explained to North Marshall District that a memo broadly summarizing the discussion would be filed in the record.

Staff explained the error, correction and corresponding adjustments. North Marshall District's representatives did not offer any objection to the corrections and tentatively indicated that North Marshall District would want the adjustments to be made to the revenue requirement even if additional customer notice was required. North Marshall District indicated that a board meeting was scheduled this week at which there would be an opportunity for them to discuss this issue with the board. Staff requested that North Marshall make a filing within 7 days indicating their position regarding the correction of the error and acceptance of the additional adjustment and indicated that if no such filing was made that it would be assumed that the tentative position provided at the IC and discussed herein remained North Marshall District's position.

North Marshall District asked about the timing of the final order and whether there would be time to complete it with the adjustments by the statutory date. Staff indicated that the expectation is that the final order could be completed by the statutory date.

There being no further material discussion, the IC was then adjourned.
