proposed rate increase under Case No. 2025-00113.

While I understand the importance of maintaining a reliable energy infrastructure, the scope of this requested increase—particularly the proposed 13.5% rise in residential rates—feels excessive and poorly timed. Many of us are already facing higher costs across the board, and a double-digit increase in electric rates would impose a significant burden, especially on fixed- and moderate-income households.

It has been published that KU is requesting an over 11% increase. During these uncertain economic times, amid rampant inflation and a questionable macro economic future ,

this request seems not only poorly timed, but also tone deaf. The people of Kentucky are already some of the poorest in the nation, with our jobs on average paying less than most of the country. Furthermore over the past five years (since the pandemic) our average household income has not kept pace with the national average. The result of these trends means that the inflation affecting our nation has a disproportionately outsized effect on KY already.

With Columbia gas winning a major price increase last year (despite the intervention of the attorney general and his office spinning the final settlement as a win - the increase was still quite large, just not as large as the company had requested) the people of the state are being pushed to a breaking point. Coupled with the fact that the unregulated price of Natural Gas has also nearly doubled this summer and , for many of the people i hear from, gas is no longer a financially sound option for heating and cooking.

Technologically, KU has already lagged far behind other national actors on the energy stage. Compared to other entities investing in more modern, cheaper sources of electricity. Approximately 80% of our energy mix is generated from coal, when nearly every other national player has diversified their mix into cheaper sources such as wind and (the recent and admittedly temporary price hike aside) natural gas. So as not to come across as an eco warrior blind to the economics of the so called 'green movement' - I will point out that my reference to wind energy is purely economical. When the ideologues on both sides of that argument are silenced there is strong empirical evidence that wind and natural gas are more cost effective sources of electricity at scale. Coal is dying across the country, due to its economic viability even in other coal rich areas, It's not just the price of the coal, but the all in operational costs are higher. Yet KU has stubbornly refused to make real meaningful investment towards a more economically sound diversification of it's energy portfolio. There is talk , there are pilot programs, and purchasing of cheap access energy from other producers in neighboring regions; but after decades of evidence and investment in other regions KU still lags woefully behind. Now they come to us, again, asking for more money so they don't have to innovate or adapt to a changing economic reality.

The people of KY should not be made to pay for a company that has not adapted to new technologies, that is beholden to infrastructure that is no longer economical. The purpose of this commission is to protect the citizens from precisely this sort of lazy economic action that derives from market monopolies (which utilities are. state sanctioned monopolies). In return for that monopoly this commission is to ensure that utilities are providing the best services for the citizens. I do not believe that economically the people of Kentucky should or are able to bear this burden nor that KU should be granted more money for their lack of foresight and a lack of investment for sustainable growth.
