Good evening Governor, I am really concerned about the proposed rate increase that Kentucky Power is requesting. I received today the highest utility bill ever, \$710. I do have the funds to pay it. I don't like that it has increased to that amount. We have a modest home of around 2100 sq foot and an inground pool. We are by no means wealthy but we are fortunate. I am a CPA and I work from home so a portion of my bill can be tax deductible. The increase just means that I will be forced to increase my rates to my clients to cover my increased cost. I'm not making any additional money - I'm just breaking even. I'm not sure if Kentucky Power has had an audit to determine if they are operating as efficiently as they could be. I just know there are many Kentuckians who aren't as fortunate as I am. I will be able to pay my bill. I will quarrel about it and be bitter but I will survive. Many others won't be able to do that. Choices will have to be made. Choices between food, electricity and medication. I am not sure what you can do but as a Kentuckian I am asking that you do whatever you can to deny their request for an additional rate increase. I've met you a few times when you've been in Prestonsburg and the region. I've thought since day one you'd be an awesome President for our country but right now we Kentuckians need you to help us.
