Hello,

The residential rate increase of 9.49% seems a bit high. However, the almost 50% cut in metering rate is ridiculous.

Currently, LG&E is charging us \$0.10838 per kWh, and they are increasing the rate to \$0.11867 per kWh - a 9.49% increase. This is higher than the yearly inflation.

However, on their net-metering service (NMS-2), they are currently paying \$0.07089 per kWh in credit. They are proposing \$0.03786 per kWh. This is a 47% decrease. This is absurd!!

I would like to know the justification for this massive decrease. We are generating more electricity with our solar panels, which is being directed to the increasing demand. We should be fairly compensated for our investment. I'm not asking for a 1-1 payment, but charging us \$0.11 per kWh and only giving us \$0.03 in return is absurd.



Dear Commissioners,

I'm writing to strongly oppose LG&E's proposed rate increases for electric and gas service. As a customer with multiple accounts this affects me personally at my home and business. In 2024, PPL reported revenue for the quarter ending March 31, 2025 was \$2.504B, a 8.68% increase year-over-year, yet they're now seeking an additional \$83 million from ratepayers. Their requested increase of 8.3% for power and 14% for gas are far out of line.

Families across Kentucky are already stretched thin with rising costs. LG&E should be expected to operate within its existing means—just like the customers it serves—instead of passing more costs onto households. If its a must, a more manageable increase should be done, not such a drastic amount.
