**THE UNITED STATES DEPARTMENT OF DEFENSE AND ALL OTHER FEDERAL
EXECUTIVE AGENCIES' MOTION TO INTERVENE**

The United States Department of Defense and all other Federal Executive Agencies (“DoD/FEA”), pursuant to K.R.S. §§ 278.310, 278.310(2), and 807 KAR 5:001, Section 4(11), by and through its attorneys, respectfully requests that the Kentucky Public Service Commission (“Commission”) permit it to intervene and become a party in the above captioned matter. In support of this Motion, DoD/FEA states as follows:

1. On May 30, 2025, Louisville Gas and Electric Company (“LG&E”) filed its Application seeking an upward adjustment of its electric and gas rates.
2. On June 18, 2025, the Commission accepted LG&E’s Application and set an intervention deadline for this matter of June 25, 2025.
3. Under 807 KAR 5:001, Section 4(11)(b), the Commission shall grant leave to intervene if it finds that “a timely motion for intervention and that he or she has a special interest in the case that is not otherwise adequately represented or that his or her intervention is likely to present issues or to develop facts that assist the commission in fully considering the matter without unduly complicating or disrupting the proceedings.”

4. DoD/FEA has a substantial interest in this proceeding because it owns and operates facilities and buildings, including Fort Knox, within LG&E's service territory and is a large user of electric power and gas. Electric and gas service provided by LG&E are a significant expense for DoD/FEA. DoD/FEA has unique concerns as a federal entity involved in national security operations with privatized on-post distribution systems that interact with LG&E's transmission and distribution systems. Accordingly, DoD/FEA's interests are greatly affected by the decisions of the Commission and another party cannot adequately represent the interests of DoD/FEA customers. If permitted to intervene, DoD/FEA will present issues and develop facts that will assist the Commission in fully considering this matter without unduly complicating, delaying, or disrupting the proceedings.

5. Undersigned counsel has been designated as the representative, pursuant to delegation of authority from the General Services Administration and 40 U.S.C. § 501(c), for matters before the Commission involving LG&E.
