1. I'd like to inquire into the <u>new projects</u> that are slated to be paid for via this annual increase of slightly south of \$163 million and will this increase remain in effect for the future? If so, for how long?

2. I estimate my total LG&E annual bill will increase by over \$250 which seems like a minor amount, especially without knowing what projects are involved and how long the rate adjustment increase will remain in effect.

My home is fairly small at 2400 sq. ft. and is very well insulated. We averaged only 760 kWh and 5.6 Mcf per month for the past 12 months and our average monthly bill was only \$172.03.
