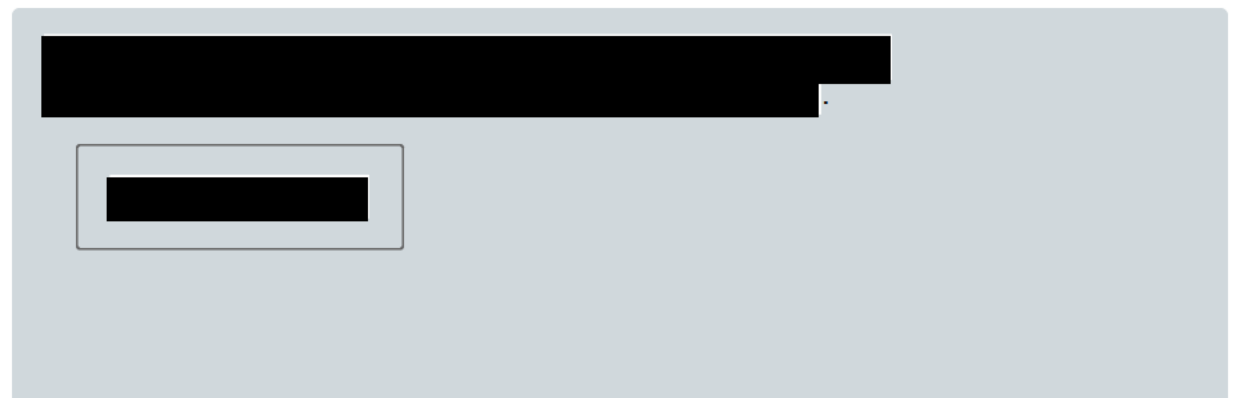

I am writing to comment on the proposed LG&E rate changes. In particular, I would like to highlight one line item - the Net Metering Service-2 Bill Credit. I invested in solar panels a several years ago and was first surprised when LG&E back billed me a year after

netting my extra production versus my usage. After that stunner, I now see that they want to reduce my rate for extra usage from \$0.07089 to \$0.03786 (a 47% reduction. This is on top of them raising their electric rates 9.5%. Combined, this would be a net increase of 115% that I'm losing on my net excess generation. Interesting they are asking to dial back usage during the heat wave to save the grid. I'm sending excess generation back to the grid and being financially punished for it.

How do I find out to better voice my opinion on this? How is it possible a fair change?

I received a letter from LGE regarding possible upcoming rate increases. This is my formal & timely written request for intervention to the public service commission. At this time LGE prices are already high with unknown fees and billing procedures. I have been billed incorrectly multiple times with no resolution. The electric companies already have a monopoly on the system, as there is no other company I could switch to at this time. I am also aware of the potential changes coming to Oldham Co with the proposed data centers. I have read how this will also be an increase to our LGE bills. This is unacceptable and if you speak to the people that live in Oldham Co, or if you drive

around a bit, you will see not many of the residents support this change. I am opposed to the data centers and to the price increases proposed.

I have a wide variety of clients, from all walks of life, and I see that everyone is struggling with our current economy. I do NOT see how anyone would be able to afford these raised rates. I also have noticed that very few people have received the insert in their mail that I received, which prompted this email. If the letter is supposed to give us a chance to speak up, everyone should receive said letter and everyone should be given enough time to respond appropriately. The public service commission needs to stand up for the people it is to be serving and give them a voice. It's almost a rhetorical question to ask if the majority of society is ok with paying more for the same service when the economy and society as a whole is struggling. I do not approve or accept these changes to be unfairly made. I am requesting a major intervention by the commission to help the people this will affect.
