The applicant(s) hereby applies for membership in and agrees to purchase electric energy from Salt River Electric Cooperative Corporation (hereinafter called the "Cooperative") upon the following items and conditions.

1. One \$25.00 membership fee shall be paid to become a member.
2. The Applicant(s) will, when electric energy becomes available, purchase from the Cooperative all electric energy used on the premises described below and will pay monthly at the rates to be determined from time to time in accordance with the by-laws of the Cooperative; provided, however, that the Cooperative may limit the amount of electric energy to be furnished for industrial uses. The Applicant(s) will pay at least a minimum monthly bill, regardless of kilowatt hours consumed.
3. If the Applicant(s) ceases to make the required payments, the Cooperative may elect its right to set off any debt the Applicant(s) owes the Cooperative against any debt the Cooperative owes the Applicant(s). This may result in the forfeiture of the Applicant(s) capital credits and/or deposits. The Cooperative will consider the Applicant's capital credits and/or deposits as security for any debt the Applicant(s) may owe the Cooperative. Any and all reasonable costs and/or collection agency fees incurred in the process of attempting to satisfy an current or past member's indebtedness to the Cooperative shall be borne entirely by those member/members.
4. The Applicant(s) will comply with and be bound by the provisions of the Articles of Incorporation and the by-laws of the Cooperative, and such rules and regulations as may from time to time be adopted by the Cooperative and filed with the PSC.
