RE: Informal Conference (IC) of July 23, 2025

Pursuant to an Order issued on July 22, 2025, a virtual informal conference (IC) was conducted on July 23, 2025. Attached is a copy of the attendance roster.

On July 3, 2025, East Casey County Water District (East Casey District) filed its responses to Commission Staff's First Request for Information (Staff's First Request) along with a motion requesting an extension of time and a motion requesting an IC be held between East Casey District and Commission Staff. The purpose of the IC was to give East Casey District the opportunity to fully respond to Staff's First Request, Item 3.

PSC Staff Attorney Michael Crum began the IC with introductions from Commission Staff and introductions from East Casey District representatives and its counsel. Staff Attorney Michael Crum then outlined the purpose and process of an IC and let all parties know that PSC Staff cannot speak on behalf of the Commission or make any final decisions.
