## **INTRA-AGENCY MEMORANDUM**

**RE:** Informal Conference (IC) of January 14, 2026

Pursuant to an Order issued on December 17, 2025, a virtual informal conference (IC) was conducted on January 14, 2026. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss East Casey County Water District's (East Casey District) responses to Commission Staff's Second Request for Information, options for addressing assessments of late payment penalties that were inconsistent with filed tariffs, the potential impact of these options on the well-being of East Casey District, and problems that may arise with finding customers who are no longer receiving service from East Casey District.

PSC Staff Attorney Michael Crum began the IC with introductions from Commission Staff and introductions from East Casey District representatives and its counsel. Staff Attorney Michael Crum then outlined the purpose and process of an IC and let all parties know that PSC Staff cannot speak on behalf of the Commission or make any final decisions.

The parties then discussed East Casey District's responses to Commission Staff's Second Request for Information. Damon Talley, counsel for East Casey District, went into great detail regarding the process of gathering customer information required to answer some of Commission Staff's questions and various avenues were discussed relating to options East Casey District may have in trying to remedy the inconsistent application of late payment penalty fees. East Casey District voiced how these options could potentially affect East Casey District's well-being and brought to Commission Staff's attention various hurdles East Casey District foresees in carrying out the options to address these concerns.

There being no further discussion, the IC was then adjourned.
