Please find enclosed and accept for filing Louisville Gas and Electric Company's ("LG&E") Responses to the Commission Staff's First Request for Information in the above referenced case.

Additionally, after reviewing this matter thoroughly, LG&E has determined that the customer should not have been charged the \$37.00 at issue in the complaint. Our billing department has now reversed that charge, as well as all late fees associated with nonpayment of the \$37.00 charge. Our customer commitment department contacted the customer earlier this week and left a voicemail advising of these changes. While we have not heard back from the customer affirmatively, we believe our recent actions should satisfy the complaint.
