I, Roy-Leon: Tyndall, Fiduciary Agent for the Estate of ROY LEON TYNDALL, hereby submit this Amended Submission to preserve rights in equity while addressing the procedural requirements outlined in the Commission's August 12, 2025 Order. This submission is made without conceding jurisdiction, and solely to ensure the record remains complete and accurate, while expressly reserving all equitable rights and protections.

I. RIGHTS PRESERVATION

Without waiving any rights, remedies, or private jurisdiction, I object to the unilateral recharacterization of my June 20, 2025 filing as a statutory complaint. That filing was and remains an equitable administrative notice and record.

This amended submission is made solely to preserve standing and ensure the record is complete, while reserving all rights under UCC 1-308, UCC 3-419, KRS 355.3-603, applicable maxims of equity, trust law, and the Law Merchant.

This submission does not constitute a waiver of private jurisdiction or trust protections, but is filed solely to maintain standing and preserve record completeness.

II. AMENDED COMPLAINT (PSC-COMPLIANT)

A. Statement of Acts/Omissions:

- City of Nicholasville Utilities refused lawful tender presented under fiduciary authority, tendered timely and in good faith.
- Continued billing and late fee assessments were made despite valid tender.
- Fiduciary appointment and set-off directives have been ignored.

B. Law/Regulation Violated:

- KRS 278.040 Grants the Public Service Commission jurisdiction over utilities and service practices, including municipal utilities in applicable contexts.
- **2. KRS 96.171 et seq.** Governs the authority and operation of municipal utility services, requiring compliance with lawful tender and billing practices.
- **3. KRS 355.3-603 (UCC Article 3)** Establishes that a valid tender of payment discharges the obligation, prohibiting continued billing or penalty charges thereafter.
- **4. 15 U.S.C. §1605 (Truth in Lending Act)** Defines and regulates finance charges; late fees and penalty assessments imposed despite valid tender constitute undisclosed and unlawful finance charges.
- **5. 15 U.S.C. §§1–2 (Sherman Antitrust Act)** Prohibits restraint of trade and monopolization; implicated where the City of Nicholasville maintains exclusive control of utility services while coercively refusing lawful tenders and penalizing alternative fiduciary settlement methods.

C. Relief Sought:

- Recognition and application of lawful tender.
- Removal of late fees and negative adjustments.
- Official acknowledgment of fiduciary standing in account administration.
- Affirm equitable recognition of all tenders and fiduciary presentments made under trust capacity.
- Directive to City of Nicholasville to honor and apply all future fiduciary tenders without penalty or delay.

D. Jurisdiction:

The City of Nicholasville operates electric and water utility services within the Commonwealth of Kentucky. Pursuant to **KRS 278.040**, the Public Service Commission is vested with jurisdiction over utilities and their practices, including municipal providers in applicable contexts. This includes oversight of billing, charges, and the fair application of payments made by customers.

Accordingly, this matter properly falls within the Commission's review for **equitable billing practices** and the application of lawful tenders. This jurisdictional acknowledgment is made strictly for the purpose of ensuring the record is complete and does not constitute a waiver of any private, equitable, or trust-based rights. All rights of objection, reservation, and non-concession of jurisdiction beyond the limited scope stated herein are expressly preserved.

III. MOTION FOR CONFIDENTIAL TREATMENT

Pursuant to **807 KAR 5:001, Section 13**, I hereby move the Commission to grant confidential treatment and sealing of specified information contained within this submission and its supporting exhibits.

The following categories of information are subject to this request:

- **1. Personal Identifiers:** Variations of the Principal's and Agent's names, mailing addresses, and NAC designations.
- **2. Account Information:** Utility account numbers, billing references, and financial transaction details.
- **3. Trust Records:** Any trust instruments, fiduciary appointments, or internal trust governance documents.
- **4. Authentication Elements:** Documents containing wet signatures, thumbprints, embossments, or fiduciary seals.

A **redacted public version** of this submission is filed concurrently, together with redacted public versions of previously submitted affidavits (Affidavit of Dishonor and Affidavit of Continuing Protest). The corresponding **Certified True Copies (CTCs) of the unredacted originals** of those affidavits are already on file with the Commission; originals remain in trust custody.

Clarification: A prior Motion for Confidential Treatment was timely mailed to the Commission using the address listed in the Commission's prior Order (P.O. Box 615, Frankfort, Kentucky 40602). That filing was returned by USPS marked "Undeliverable as Addressed." The failure of delivery was not attributable to the undersigned, as the Commission's own designated mailing address was used. This Amended Submission therefore fully reasserts and preserves the Motion for Confidential Treatment for the official record.

Granting confidential treatment is necessary to:

- Prevent undue invasion of privacy and disclosure of sensitive personal identifiers;
- Protect against breach of fiduciary duties owed to the Principal and the trust;

- · Avoid risk of misuse, forgery, or unlawful reproduction of private instruments: and
- · Preserve the integrity of trust records and fiduciary communications consistent with equitable obligations.

This request is narrowly tailored to protect only the categories listed above and is not intended to restrict public access to the general substance of this proceeding.

IV. RESERVATION OF RIGHTS

All rights, defenses, objections, and remedies are hereby expressly reserved. This submission is made strictly **By Special Appearance Only** and does not constitute a general appearance, waiver, or concession of jurisdiction.

Nothing herein shall be construed as a waiver of:

- Private or equitable jurisdiction,
- Trust protections and fiduciary immunities,
- Rights under the Uniform Commercial Code, including UCC 1-308 (reservation of rights) and **UCC 3-419** (conversion of instruments),
- · Rights under the Law Merchant, maxims of equity, common law, and admiralty/maritime law as applicable,
- Rights and remedies under Kentucky law, federal law, international law, and the Law of Nations.

This submission is made without prejudice to any private, equitable, administrative, judicial, federal, or international remedy now existing or arising in the future. The Fiduciary Agent expressly reserves the right to pursue further relief or enforcement in any competent forum, including but not limited to the Commission, the courts of Kentucky, the federal courts, international tribunals, and appropriate oversight authorities.

I. AUTHORITY AND STANDING

- I, Roy-Leon: Tyndall, being of lawful age and competent standing, do hereby affirm and declare under penalty of perjury and by private fiduciary oath, that the following is true, correct, and complete to the best of my knowledge and belief:
 - **1.** I am the lawfully appointed Agent for ROY L TYNDALL, the Principal in the above-referenced matter, acting in good faith with all rights reserved under private trust, commercial law, and equity.
 - **2.** This affidavit is executed for record and presentment as an act of lawful notice, evidentiary preservation, and demand for remedy.

II. PRESENTMENT OF TENDER

- 3. On May 29, 2025, I caused to be mailed via USPS Certified Mail (Tracking No. REDACTED 1910) a full Notice of Default and Final Tender for Full Settlement to the City of Nicholasville.
- **4.** The packet included:
 - A notarized Affidavit of Facts, Constructive Default, and Equitable Interest
 - A properly endorsed utility billing statement serving as tender
 - A signed Cover/Conditional Payment Letter
 - A Sealed Lawful Presentment Sheet
 - All executed with jurisdictional clarity, reservation of rights, lawful tender protocol, and fiduciary authority

4.1. Fiduciary Authority Declared:

The undersigned Agent, Roy-Leon: Tyndall, is acting in full lawful capacity under a

duly executed **Special Durable Fiduciary Appointment**, dated 4 day of 2025, retained in original form within the trust binder record set. Said appointment affirms fiduciary authority over all administrative and municipal accounts affecting the Principal, including but not limited to utility, tax, licensing, mortgage, and student loan accounts.

A **Certified True Copy** of this fiduciary appointment may be included herein for administrative verification and public notice. Additional copies may be provided to the **Kentucky Secretary of State**, **Attorney General**, **Public Service Commission**, or other relevant agencies as necessary to preserve the lawful record and affirm jurisdiction.

- 5. Tender was made in accordance with:
- UCC 3-603(b) / KRS 355.3-603(1):

"If tender of payment of an obligation... is refused, there is discharge to the extent of the amount of the tender."

• 12 U.S.C. § 411:

"Federal reserve notes... shall be redeemed in lawful money on demand at the Treasury..."

• 31 U.S.C. § 5118(a)(2):

"An obligation may not require payment in gold or a particular kind of coin or currency."

III. DISHONOR AND REFUSAL

6. On **June 10, 2025**, I received the City's written response (dated June 5, 2025), stating:

"The payment... is not an accepted payment method by the Utility."

- **7.** The City's response:
 - Offered no rebuttal to the affidavit or fiduciary authority of the Agent
 - Refused to honor setoff or recognize lawful discharge under UCC and KRS
 - Attempted to compel payment through exclusive use of commercial portals and institutions
 - Failed to cite any statute, ordinance, or law validating such rejection
- **8.** The City's refusal constitutes:
 - Dishonor of lawful tender under KRS 355.3-603(1) and UCC 3-603
 - Breach of fiduciary and statutory duty to accept lawful means of discharge
 - Violation of commercial fairness and good faith as required by:
 - KRS 355.1-103(b):

"Every contract or duty within KRS Chapters 355.1 to 355.9 imposes an obligation of good faith in its performance and enforcement."

- 9. Their commercial coercion through private payment channels further violates:
- **KRS 369.102(1)(a)** -affirms the right to execute documents and perform obligations in non-electronic written form
- Kentucky Constitution § 2:

"Absolute and arbitrary power over the lives, liberty and property of freemen exists nowhere in a republic..."

• Kentucky Constitution § 14:

"All courts shall be open... and every person for an injury... shall have remedy by due course of law."

Kentucky Constitution § 177:

"No city or town shall... delegate its duties... to any private person or corporation."

IV. CONSTITUTIONAL BREACH AND FEDERAL SUPREMACY

10. The City's actions also violate the **United States Constitution**, which supersedes all conflicting municipal or state policies:

• Article VI, Clause 2 - Supremacy Clause:

"This Constitution... shall be the supreme Law of the Land... anything in the Constitution or Laws of any State to the Contrary notwithstanding."

• 5th Amendment - Due Process:

"No person shall... be deprived of life, liberty, or property, without due process of law..."

• 14th Amendment, Section 1 - Equal Protection & Due Process:

"Nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny... equal protection of the laws."

• 1st Amendment - Right to Petition:

"Congress shall make no law... abridging... the right of the people... to petition the Government for a redress of grievances."

11. As a municipal service entity operating under public authority, the City of Nicholasville is bound to uphold these rights. Their refusal to engage in lawful remedy and reliance on exclusive commercial systems constitutes a direct **constitutional breach**.

V. LAWFUL RECORDING OF DISHONOR

- **12.** I hereby record this dishonor and administrative breach in trust, and reserve all rights under law and equity to pursue remedy.
- **13.** All unrebutted statements in the original affidavit are hereby affirmed and carried forward.
- **14.** Per **KRS 421.210** and **KRE 1001–1002**, this sworn affidavit stands as **prima facie evidence** of dishonor and unlawful interference.



VI. PRESERVATION OF RIGHTS AND RECORD

- **15.** The original of this affidavit is retained in the trust archive.
- 16. A Certified True Copy (CTC) may be presented to public officers and lawful bodies as necessary.
- **17.** All rights are reserved. No waiver of trust, title, remedy, or jurisdiction is granted or implied.

KNOW ALL MEN BY THESE PRESENTS:

I, the undersigned, **ROY L TYNDALL** (hereinafter "Principal"), being of competent mind and full standing under law and equity, do hereby appoint **Roy-Leon: Tyndall**, my trusted fiduciary, as **Special Durable Fiduciary Agent** (hereinafter "Agent") to act on my behalf in all lawful, equitable, and administrative matters associated with any and all utility, tax, property, voter, vehicle, licensing, or other public accounts, instruments, or files opened in or under any name or designation of the Principal.

Naming Variations:

For the purposes of this appointment, the name "ROY L TYNDALL" shall be construed to include and apply to all stylized, reversed, abbreviated, derivative, or administratively created renderings of the Principal's name including, but not limited to:

- ROY LEON TYNDALL
- TYNDALL, ROY L
- Roy Tyndall and any other variation assigned by corporate, municipal, or agency records. The family name is properly spelled Tyndall/TYNDALL.

I. APPOINTMENT AND STANDING

- 1. This durable fiduciary appointment is made for the express purpose of:
 - Investigating, auditing, and remedying long-standing financial coercion;
 - Executing lawful tender and asserting trust rights:
 - Correcting any contract or administrative action entered into without full disclosure or under presumed jurisdiction;
 - Securing full closure, discharge, or return of value belonging to the Principal or his Estate.
- **2.** The Agent is authorized to correspond with, give notice to, or file equitable instruments before:

ROY L TYNDALL - Principal • Roy-Leon: Tyndall - Agent

- The City Attorney, Mayor, or administrative officers of Nicholasville;
- The Kentucky Public Service Commission, Kentucky Secretary of State, and Attorney General;
- Any municipal, county, or state officer in receipt of fiduciary notice related to any affected account.

II. ACCOUNT SCOPE AND RETROACTIVE STANDING

- 3. This appointment applies to all:
 - Active utility accounts;
 - Dormant, closed, reassigned, or improperly retained accounts;
 - Accounts historically held in the name of any estate member or household representative, including the Principal's lawful spouse.
- 4. The Agent is authorized to:
 - Investigate and audit all billing and payment histories;
 - Identify overpayments, withheld credits, unauthorized charges, or charges imposed in dishonor of lawful tender;
 - Address any failure to properly recognize affidavits, fiduciary notices, or trust-based settlement instruments.
- 5. This appointment includes standing to act retroactively, correcting and preserving all rightful interest of the Principal.

III. REMEDY AND RETURN OF VALUE

- **6.** The Agent is authorized to:
 - Deliver notice of default, dishonor, or fiduciary interference;
