ORDER

On August 12, 2025, Clark Energy Cooperative, Inc. (Clark Energy) tendered an application for an alternative rate adjustment pursuant to 807 KAR 5:078. Clark Energy has proposed that its rates go into effect on September 12, 2025.

Under the procedure established in 807 KAR 5:078, the Commission finds that the application meets the standards for the streamlined procedure and should be accepted for filing and processed according to the regulation. As required by 807 KAR 5:078 Section 8(7),¹ the Commission finds that Clark Energy's Annual Reports for 2023² and 2024³ should be incorporated by reference into the record of this proceeding.

The Commission finds that a procedural schedule should be established for the orderly processing of this matter. In accordance with 807 KAR 5:078, the schedule shall include a seven-day deadline to file comments regarding Clark Energy's request to

proceed under that regulation. The procedural schedule is set forth in the Appendix to this Order.

IT IS THEREFORE ORDERED that:

- 1. Clark Energy's application for an alternative adjustment of its rates, pursuant to 807 KAR 5:078, is accepted for filing as of August 12, 2025.
- 2. Clark Energy's 2023 and 2024 Annual Reports are incorporated by reference into the record of this proceeding.
- 3. The procedural schedule set forth in the Appendix attached to this Order shall be followed.
- 4. Clark Energy shall respond to all requests for information propounded by Commission Staff, whether identified on the procedural schedule or otherwise, as provided in those requests.
- 5. Any party filing a paper with the Commission shall file an electronic copy in accordance with the electronic filing procedures set forth in 807 KAR 5:001, Section 8. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked. The Commission directs the parties to the Commission's July 22, 2021 Order in Case No. 2020-00085⁴ regarding filings with the Commission.
- 6. As set forth in 807 KAR 5:001, Section 4(11), a person requesting permissive intervention in a Commission proceeding is required to demonstrate either (1)

a special interest in the proceeding that is not adequately represented in the case, or (2) that intervention is likely to present issues or develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. Therefore, any person requesting to intervene in a Commission proceeding must state with specificity the person's special interest that is not otherwise adequately represented, or the issues and facts that the person will present that will assist the Commission in fully considering the matter. A mere recitation of the quantity of utility service consumed by the movant or a general statement regarding a potential impact of possible modification of rates will not be deemed sufficient to establish a special interest.

7. Any motion to intervene filed after the date established in the procedural schedule attached as an Appendix to this Order shall also show good cause for being untimely. If the untimely motion is granted, the movant shall accept and abide by the existing procedural schedule.
