Case No. 2025-00257, *Electronic Application of Kentucky Power Company for (1) A General Adjustment of Its Rates for Electric Service; (2) Approval of Tariffs and Riders; (3) Approval of Certain Regulatory and Accounting Treatments; and (4) All Other Required Approvals and Relief*

Pursuant to Order issued on December 12, 2025, an informal conference was conducted on December 15, 2025. Attached is a copy of the attendance roster.

The purpose of the informal conference was to discuss settlement of this matter as between applicant Kentucky Power and intervenors: the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention (Attorney General), Kentucky Industrial Utility Customers (KIUC), Kentucky Solar Industries Association, Inc. (KYSEIA), SWVA Kentucky, LLC (SWVA); and Joint Intervenors Appalachian Citizens' Law Center, Kentuckians for the Commonwealth, Kentucky Solar Energy Society, and Mountain Association (Joint Intervenors).

Kentucky Power representatives summarized a settlement term sheet prepared by Kentucky Power. Intervenor counsel was permitted to ask questions. Additional discussion was tabled for the additional, in-person settlement conference schedule for December 17, 2025 at 9:00 a.m.
